NX W is the complementary USB control surface to Obsidian Control Systems ONYX platform. The NX W utilizes a comparable ergonomic layout to the NX K and NX P. Through its USB-C connection the NX W provides a responsive, professional hardware surface to operate ONYX on any PC system without compromises. Any user of ONYX will feel instantly familiar with the NX W and no setup or additional installation is required. Simply plug it into a user-provided PC with ONYX and get started instantly.

NX W provides extensive connectivity with 4 DMX/RDM ports, Gigabit Ethernet Output for X-NET and streaming DMX data while unlocking 16 Universes of control when connected to ONYX on a PC. A protected USB slot allows the installation of an ONXY License Key to expand the system up to 128 Universes.

You must update your PC or controller to the latest version of ONYX before using it for the first time, and periodically check the website for updates.

PC SYSTEM REQUIREMENTS FOR NX W

ONYX is designed for PC systems with a multi-touch touchscreen. Without a touchscreen, the user experience may be suboptimal.

The PC should meet these minimum recommendations; higher universe counts may require more powerful systems:

- 8th generation Intel Core Processor or newer (or comparable AMD processor)*
- 16 GB RAM
- SSD storage drive
- 40GB+ available disk space for software, DYLOS factory content and storage
- Widescreen monitor, minimum 1280 wide, 768 high (capacitive multi-touchscreen recommended)
- USB3.x port.

User account must be local administrator.

CONNECTIONS: POWER

The Obsidian Control Systems NX W accepts AC mains power at 100-240V 50/60Hz. Do not connect it to power outside this range. Damage resulting from incorrect connection is not covered under warranty.


North America: A cable with a NEMA 15-5P plug is provided for use with the NX W in the USA and Canada. This approved cable must be used in North America.

Rest of the world: The provided IEC cable is not fitted with a country-specific plug. Install only a plug that meets local and or national electrical codes and is suitable for the country's specific requirements. Power input specifications may vary by region; consult the provided power supply documentation.

A 3-prong grounded-type (earthed type) plug must be installed following the plug manufacturer's instructions. The table below shows some possible pin identification schemes; if the pins are not clearly identified, or if you have any doubts about proper installation, consult a qualified electrician.


To apply power to the product:

- 1. Set the power switch to OFF.
- 2. Connect the locking connector to the back of Mains Input port.
- 3. Plug the cable into a grounded outlet.
- 4. Connect the USB-C cable to the PC, or use the included adapters to connect it with the PC.
- 5. Turn the power switch to ON.



MAINTENANCE

The Obsidian Control Systems NX W is designed as a rugged, roadworthy device. The only required service is occasional cleaning. For other service related concerns, please contact your Obsidian Control Systems dealer, or visit www.obsidiancontrol.com.

Any service that is not described in this guide must be carried out by a trained and qualified Obsidian Control Systems technician.

As any computer, the NX W requires periodic cleaning. The schedule relies on the environment in which the controller is operated. An Obsidian Control Systems technician can provide recommendations if necessary.

Never spray cleaner directly onto the console surface; always spray into a lint-free cloth and wipe it clean. Consider using cleaning products designed for cellphone and tablet devices for cleaning a lighting console.



Important! Excessive dust, dirt, smoke, fluid build-up, and other materials can degrade the performance of the NX W controller, causing overheating and damage to the unit that is not covered by the warranty.
